• The Fund has a broad geographical mandate, rather than an arbitrary one prescribed by an index. Its strategy spans markets that are variously categorized as "frontier," "emerging," and "developed."

Foster notes, "We believe an unconstrained approach of this sort will serve shareholders best. The flexibility that it affords will allow the Fund to readily adapt as the world's markets and economies continue their rapid and complex evolution."

Foster founded Seafarer Capital Partners last spring after a long career at Matthews Capital Management, adviser to the Matthews Asia Funds. While at Matthews, Foster was named assistant manager of the firm's Growth & Income strategy in 2003, and served as its lead manager from 2008 to 2011. In addition, he served as the firm's acting Chief Investment Officer and its Director of Research, and launched and was a manager of the firm's India and Asia Dividend Funds. Foster was directly responsible for the management of over \$4 billion in emerging market assets.
